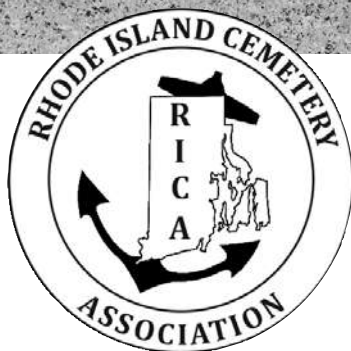

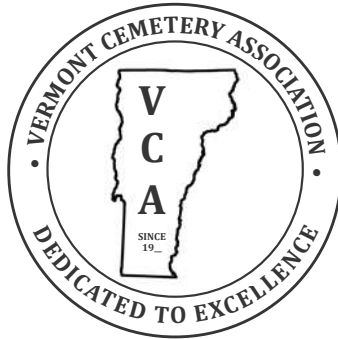

New England Cemetery Association BY-LAWS

(The New England Cemetery Association is also referred to as the Association within this document)

as amended June 18, 2024

Article 1: OFFICERS: Duties and Responsibilities of Officers and Directors: It is understood that all officers and directors will assume the monetary obligation to attend all meetings and events of the Association.

Section 1: President: Acts as the spokesperson for the Association, Chairs all Board and Association meetings, Appoints committee members and chairpersons as per the Constitution and By-Laws, Establishes ad hoc committees, Responsible for the annual budget, Sets agenda for Board meetings, Responsible for the planning of the Annual Meeting and Conference of the Association, Follows protocol of the Constitution and By-Laws of the Association, Serves as an Ex-officio member of all committees, Serves as Immediate Past President for the year following his/her term.

Section 2: Vice President: Responsible for all of the duties and responsibilities of the President in the event the President is absent, Assist in preparations for the Annual Conference program in coordination with the President, Assist the President in representing the Association, Assist in developing the Annual Budget.

Section 3: Treasurer: Acts as the Chief Financial Officer of the Association including (1) Being the chief signatory on all financial accounts of the Association (2) Is bonded (3) Responsible for the filing of legal and regulatory documents (4) Assists the President and Chairpersons in the development of budgets including the presentation and maintenance of such (5) Pays all invoices for the Association (6) Retains financial records, both current and historical (7) Assists all financial committees (8) Keeps inventory and maintains all physical assets (9) Assures all Board approved insurance policies are up to date. The Treasurer is eligible for compensation at the discretion and approval of the Board.

Section 4: Secretary: The Secretary will act as the clerk for the Association including (1) Act as the Recording Secretary, keeping minutes of Board and Membership meetings (2) Responsible for correspondence at the direction of the Board (3) Responsible for the timely issuance of all notices as required by the Constitution and By-Laws of the Association (4) Maintains the current roster of membership (5) Assists the President (6) Retains historical documents including, but not limited to, meeting minutes, the Charter, Constitution and By-Laws of the Association. The Secretary will work closely with the Treasurer receiving all payments presented to the Association, Assist the Chairpersons of the Annual Conference and other educational events, Assist in the publication of official Association publications. The Secretary is responsible for the orderly execution of all Association elections and other votes made by the Membership in accordance with the Constitution and By-Laws of the Association. The Secretary is eligible for compensation at the discretion and approval of the Board.

Section 5: Immediate Past President: As chairperson of the Nominating Committee the Immediate Past President must inform and educate qualified candidates of their duties and responsibilities so that they may effectively serve on the Board of Directors and/or as an officer of the Association. The Immediate Past President serves as a voting member of the Board of Directors for the year immediately following his or her term as President of the Association, attending all meetings and functions of the Association and assisting the President as the need shall arise.

Section 6: Directors: A Board member does not represent the state from which he or she is from, but represents all New England cemeteries. Directors shall attend all meetings and official functions of the Association. They shall serve on committees and be available to assist officers and committee chairs as assigned.

Article 2: ELECTIONS:

Section 1: Elections for all positions will be held during the annual meeting.

Section 2: Only Active Members, as enunciated in Article 3, are eligible to serve as an Officer or Director. They shall be elected by a majority vote of those members who are in attendance and voting during the Annual Meeting

Section 3: If a Director dies, resigns or misses three (3) consecutive meetings, that Director's office may be vacated, and the Board shall be authorized to appoint a replacement to serve the unexpired term of the replaced Director. The Board has the option to elect temporary officers until the following scheduled election.

Article 3: MEMBERSHIP:

Section 1: *Active Member:* Shall consist of members who are directly associated or employed, other than a contractual agreement, with a cemetery within the NEW ENGLAND STATES. Active members shall have the right to participate in meetings, hold office and vote on matters of the Association.

Section 2: *Honorary Member:* Shall consist of members whom the Association deems worthy of this distinction. Honorary members shall pay no dues. They may attend and participate in all functions and serve on any committee to which they may be appointed. They shall not have the right to vote or hold office in the Association.

Section 3: *Associate Member:* Shall consist of members who are directly associated or employed, other than a contractual agreement, with a cemetery outside of the New England States, who are interested in the activities and wellbeing of the New England Cemetery Association. The Associate member may attend and participate in all functions, and serve on any committee, to which they may be appointed. They shall not have the right to vote or hold office in the Association.

Section 4: *Supplier Member:* Shall consist of members who are an individual, firm or corporation supplying any materials or services used by an Active or Associate member of the cemetery industry. Supplier members may attend and participate in all functions and serve on any committee to which they may be appointed. They shall not have the right to vote or hold office in the Association. However, up to one, but no more than two supplier members shall be designated as a Supplier Liaison, by the President, with approval from the Board. These individuals will be members of the Board of Directors but do not have the right to vote.

Article 4: COMMITTEES: Auditing, Finance, Membership, and Allied Industries Committees consisting of three members each, or such other members as may be fixed by the Board of Directors, shall be appointed by the President as soon as practical after the Annual Meeting. They shall perform the usual duties of such committees. Additional committees may be created by the Board of Directors, with such duties as it may assign.

Section 1: *Nominating Committee:* The Nominating Committee shall consist of the five (5) most recent Past Presidents who are still active members, with the immediate Past President to be Chairperson. The Committee shall be given notice by the President at least two months prior to the Annual Meeting and they shall make a written report before the Annual Meeting of their nominations for Officers and Directors. Other nominations for any office may be presented at the election, signed by at least ten (10) active members.

Section 2: *Certification Committee:* The Certification Committee shall consist of the President, Vice-President, Secretary, Treasurer and the most immediate Past President still active, with the President serving as chairperson. The Committee shall meet at least two times each year to review and consider any pending applications for designation as a New England Certified Cemetery Professional. The presentation of certificates will be made at the Annual Meeting and Conference or at the Management Seminar, at the discretion of the recipient. The Committee may make changes to the Certification Program as may be required from time to time. The Board of Directors must approve all changes.

Section 3: Education Committee: The Education Committee shall consist of the President (as Chair), the Vice President, the Treasurer and any additional members as may be appointed by the President. They shall be responsible for any educational programs produced or sponsored by the Association with the approval of the Board of Directors.

Section 4: Communications / Media Committee: The Communications / Media Committee shall consist of at least three (3) members appointed by the President and approved by the Board of Directors. This committee shall be responsible for all communications within the organization as well as with the general public. Any and all information to be shared by the NECA whether verbal, print, or electronic, shall be in keeping with the educational and non-profit nature of the Association. The Board of Directors and its' committees have the right to deny or decline the distribution of any content deemed to be contrary to the nature of the Association. The final decision on information and content found to be in contradiction with the nature of the Association shall be made by the Board of Directors. One of these committee members shall be designated as the Editor of the Association's newsletter (The New Englander) and one of these members shall be designated as the editor of the annual Membership Directory and Resource Guide.

Article 5: DUES:

Section 1: The annual dues for the Association shall be set, from time to time, at the Annual Meeting by a majority vote of the members present, provided notice of any proposed change in the dues be stated on the call of the meeting. All dues shall be payable January first of each year. Any person joining the Association during the calendar year will be liable for the annual dues for that year and said dues are payable upon acceptance of the membership application.

Section 2: Special Assessments: Special assessments of any amount determined by the Board of Directors to be necessary to cover the expense of any meeting may be made, the amount to be stated on the notice of the meeting and payable at such meeting.

Section 3: Arrears: While any member is two years in arrears in his/her dues, he/she may be dropped from membership by a vote of the Board of Directors.

Article 6: INVESTMENT POLICY: Investments are to be conservative and diversified in order to preserve capital, achieve proper liquidity and avoid inappropriate concentration of credit and interest rate risk, while striving to maximize returns. The Finance committee shall make recommendations to the Board of Directors, who shall have the final authority on investment decisions.

Article 7: DISCIPLINE:

Section 1: Any member being two (2) years in arrears in the payment of dues or fees or charges in excess of the dues or programs, materials, etc., which are specifically requested by the member and billed to such member shall be suspended and shall be so notified in writing and may be dropped from membership by a vote of the Board of Directors. Such member, upon payment of arrears within thirty (30) days, may be reinstated by the Board.

Section 2: Any member may be expelled for cause by three-fourths vote of all members of the Association present and voting as expressed by secret ballot and on charges set forth by the Board, including any violation of the Constitution or the By-Laws, provided the member against charged has been given no less than one month's notice by registered mail and an opportunity to appear at a general meeting to contest such charges.

Article 8: AMENDMENTS TO BY-LAWS: These By-Laws may be amended by a two-thirds vote of those members present and voting at the Annual Meeting, provided notice of each proposed amendment be provided to the members at least two (2) weeks prior to the meeting.

Article 9: PARLIAMENTARY AUTHORITY: The current edition of "Robert's Rules of Order" shall be the final source of authority in all questions of parliamentary procedures when such rules are not inconsistent with these By-Laws.



New England Cemetery Association CONSTITUTION

as amended June 18, 2024

Acknowledging the common desire to preserve, maintain and embellish cemeteries within the six New England States, we have come together to create the New England Cemetery Association. This association of individuals, who have a common interest in and are employed by or have an ownership of a cemetery within the bounds of the New England States, is dedicated to the dissemination of knowledge and ideas pertaining to the preservation of, management of and the establishment of cemeteries for the benefit of the citizens of New England.

Article 1: NAME: The name of the corporation shall be NEW ENGLAND CEMETERY ASSOCIATION (also referred as the Association within this document).

Article 2: PURPOSE: The purpose for which this corporation is organized shall be the collection and dissemination of information of an educational nature pertaining to the operation, maintenance and improvement of New England Cemeteries, both active and historical.

Article 3: MEMBERSHIP: The Association shall consist of the following classifications: Active, Honorary, Associate and Supplier member. No person shall be eligible for membership to the Association who cannot subscribe to the Code of Ethics adopted by the New England Cemetery Association as enunciated in Article 6. Conduct in violation of said code on the part of any member shall be grounds for registration of a complaint to the Board of Directors requesting expulsion. Membership in any of the Association classifications must be approved by the Board of Directors.

Article 4: OFFICERS AND DIRECTORS: The officers of the Association shall be: President, Vice President, Secretary, Treasurer and these officers shall be members of the Board of Directors. They shall be elected by ballot at the Annual Meeting, to take office at the adjournment thereof. The terms of office of their predecessors shall then expire. They shall have the usual duties as set forth in the New England Cemetery Association By-Laws and any other duties imposed by the Board of Directors and act as the Executive Board of the Association. The Secretary shall act as clerk to the Directors. There shall be elected a minimum of four (4) Directors with a maximum of eight (8). Two (2) of these Director positions shall be filled by Past Presidents of the organization. All Directors will be elected for a term of one year. The Directors shall have the usual duties as set forth in the New England Cemetery Association By-Laws. In addition to the elected Directors, the immediate Past President shall be a member of the Board of Directors. At no time shall there be fewer than nine members on the Board of Directors nor more than thirteen members.

Article 5: BOARD OF DIRECTORS: The management of the affairs of the Association, including the power to deal with the properties in any manner shall be in the hands of the Board of Directors. Vacancies in any office for any reason shall be filled by the Board of Directors from the active membership for the balance of the unexpired term, except in the case of a vacancy in the Board of Directors. The Board of Directors may fill the vacancy for the balance of the year and a Director shall be elected at the next Annual Meeting to fill the unexpired term of any such Director. A quorum shall be comprised of 50% of the Board of Directors who shall be present for the valid transaction of business. An agenda shall be distributed in advance to each member of the Board of Directors. Only items on the agenda may be dealt with at this time, motions arising at any meeting of the Board of Directors will be decided by a majority of those present.

Article 6: CODE OF ETHICS: The fundamental purpose for which this Association exists is to inspire continued effort toward the improvement of American cemeteries. To this end it seems essential that we declare the principles and ethics upon which rests the successful administration of our affairs.

We believe that it is necessary in such a declaration that we here condemn the practice of selling cemetery property for speculative or investment purposes, or upon the promise of re-sale at a profit. That such a practice is detrimental to public interest is self-evident. It defies the fundamental concept upon which the development of our industry has been predicated and constitutes a threat to our advancement by abusing the privileges and prerogatives which we administer as a public trust.

We consider that fair dealing with the general public requires that we devote our attention to enlightenment of the people with whom we come in contact, and we charge ourselves with the responsibility of guiding and assisting individuals in their relations with us to the end that their interests be well served. We believe in the fundamental precepts of fair competition, dedicating ourselves to the preservation of those standards which were indigenous to the founders of this Association, and which have been followed by us until an unwritten code of ethical conduct has become inherent on our method of operation.

We believe that the purposes for which this Association exists cannot be passive in nature, but that we are charged further with the responsibility of educating others to the high standards of conduct herein defined.

We offer this declaration as a basic code of ethical conduct to which we, as an Association and as individual members, subscribe - placing our faith and credit in the broad basic principles here enunciated.

Article 7: MEETINGS: Each year there shall be an Annual Meeting of the Association and any such other special meeting as desired may be called by the President with the approval of the Board of Directors or on a vote of the Association. The exact time and place of the meeting shall be set by the Board of Directors and may include virtual meeting so long as there is a method of communication and voting. The call of the meeting shall be delivered either by hand, email or United States Postal Service, to the membership at least thirty (30) days before the time set, therefore.

Article 8: SUNSET CLAUSE, DISSOLVING of the CORPORATION: At such a time the Board of Directors deems the dissolution of the New England Cemetery Association necessary, the Board of Directors may make a recommendation, in writing, hand delivered, emailed, or mailed by United States Postal Service, to the membership of the Association. Such a recommendation shall be made, at minimum, 30 days prior to any annual meeting or special meeting called by the Board of Directors. Approval of the Dissolution of the Corporation shall require an affirmative vote of three-fourths of the members present and voting. All assets of the New England Cemetery Association shall be divided among the six New England state cemetery associations, to the percentage of members from that state.

Article 9: CONSTITUTIONAL AMENDMENTS: This constitution may be amended by a two-thirds vote of those present and voting at any Annual Meeting, provided notice of each proposed amendment be stated on the call of the meeting.

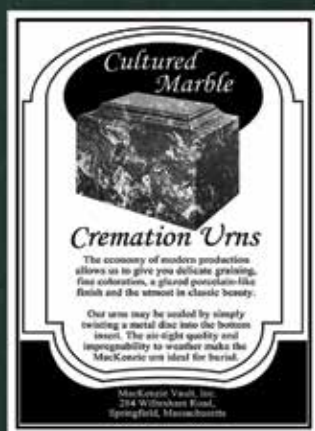
