

Over 165 trees have been catalogued, 60 of which will be labeled with their common name and botanical name. The cemetery plans to provide educational signage, guided tours, and community events focused on tree care, environmental conservation, and the importance of biodiversity.

"We are thrilled to join the ranks of accredited arboreta around the world," said Brown "Our team has worked hard to enhance the landscape with a variety of trees that are both beautiful and beneficial to the local ecosystem.
