

While education about grief in general is often limited, education about the impact of vicarious grief-the grief we experience in response to another person's direct loss-is even less common. Deathcare workers of all kinds, including cemetery workers, are exposed regularly to the grief process, both of those they serve directly and the general public, and are therefore at a higher risk of experiencing vicarious grief. Despite the silence around it due to both lack of education and social stigma, vicarious grief can have a profound impact on our wellbeing and on the wellbeing of our colleagues. In this session, we will learn more about vicarious grief, share our experiences, and discuss best practices for managing and integrating our vicarious grief into both our professional and personal lives.
