REMEMBERING BARBARA BROOKS

Hello, NECA Cemeterians & Suppliers!

Back in December of 2024, I was contacted by Dale Fiore from Evergreen Cemetery in New Haven, CT., who was calling on behalf of the late Barbara Brooks. Mr. Fiore is a Past-President of NECA, and he explained that Ms. Brooks was a longtime member of The Rhode Island and New England Cemetery Associations who served as treasurer of NECA from 2003 through 2009. Barbara was in attendance for all New England Cemetery events, including the midwinter gathering, the annual meeting & conference and the fall management seminar. Barbara received her New England Cemetery Association Professional Achievement Certification and Honorary Member status. As Treasurer of the association, Barbara kept a keen eye on the books and financials, and perhaps most importantly, was a longtime ambassador at the hospitality room, where she invented many games, including the infamous 'Screw your Neighbor.' She loved a good lottery scratch ticket and playing the slots at the casino. Barbara also toured much of The United States behind the wheel of an RV with friends, and it was rumored that she held a Pilot's license and flew planes, too. In 2017 Barbara passed away and was laid to rest in her family lot at River bend Cemetery in Westerly, Rhode Island. Dale went on to express his disappointment that Barbara's grave was unmarked, and wondered if there was thing the organization could do to see about getting her properly memorialized. I told him that I understood and appreciated his concern, and that I would see what I could do.

Barbara had been interred on an old family estate lot, so the first thing we needed to do was get permission from the family to install a marker on her grave. We were quickly able to get in contact with the current proprietor of the lot, and he was very much on board to get Barbara memorialized. He stated it had never sat right with him that she was not properly acknowledged, but stated that as only a cousin, he did not think it was his place to have it done. With his permission, we contacted Richard Brooks (no relation to Barbara) from Buzzi Memorials, a local monument company that we work with quite often, explained the situation, and asked if they would be willing to make the marker for us. Mr. Brooks was happy to get involved and offered a matching 2' X 1" granite marker with engraving for the incredible price of only \$500!

The last step was to secure the \$500 in funding for the marker, as the foundation and installation was to be—handled by River Bend Cemetery staff free of charge. The matter was discussed at the NECA Board Meeting prior to the Laffond Seminar in December, and it was decided that we would start a collection among the attendees at the Seminar to see if we could raise the money. I made one announcement on the first day, and within about 5-10 minutes, we raised the money that we needed. Kelly Perry, Karin Sprague, Mary Anne Hawthorne, Dave McKenna, Nick Ricciardi, Allan MacKinnon, Robbin Kelley, and the Elm Grove Cemetery in Rhode Island were among the very generous contributors. The marker was then made and installed in April of 2025 (see picture), so, a huge thank you to Dale Fiore, Richard Brooks from Buzzi Memorials, the NECA Board of Directors, and for all those that contributed to get one of our own memorialized in the way that she deserved. May she rest in peace.

Please join me in congratulating these outstanding members and offering them assistance and encouragement.

Following the Annual Meeting the attendees were introduced to Jeff McManus, Founder and Lead Cultivation Officer of The Jeff McManus Group. As the Keynote Speaker, Mr. McManus shared with the group his experience in building a team of leaders, "turning weeders into leaders". He shared what inspiring leaders do differently and why we love working for them. He highlighted 4 characteristics most admired in a leader – Honest, Competent, Inspiring and Forward Thinking. Being a leader is more than a skill; it is about building a relationship with your team.

Next Hayden Burrus presented a thought-provoking program on perpetual care funds. Your \$30,000.00 budget this year will cost you \$771,000.00 in 100 years based on the average inflation rate of 3.3%. He stressed that your PC plan should be based on a 100-year horizon. He suggested that you should re-evaluate your plan as needed, at least every 5 years. You will need to make changes as required including your contribution rate, your pricing, your maintenance budget as well as your investment policies. His presentation was certainly eye-opening.

The educational program was concluded by a presentation by Ashlynn Rickord Werner. According to Ashlynn, every headstone or marker tells a story if we know how to listen. She shared her experiences of opening up historical cemeteries to the public as learning places. She stressed that doing so will allow you to expand your community's interest in your property and create an added revenue stream. Many of our member cemeteries have been successful in inviting the public to partake in their history and Ashlynn is a very good resource for guidance if these endeavors are in your future.

As an added bonus, the attendees were treated to a trolley tour of St. Ann Cemetery in Warwick on Wednesday morning. NECA member Anthony Carpinello guided us through the Providence Diocesan cemetery describing the many unique sections that were developed over time, utilizing the then current design features. The highlight was the Sts. Peter and Paul Mausoleum constructed by supplier member, McCleskey Mausoleums in 2021.

If you would like to partake in future NECA educational activities please keep in mind the upcoming Frederick Laffond Cemetery Management Seminar scheduled for December 8th through the 10th, 2025. As usual, this comprehensive program will be presented at the Publick House in Sturbridge, MA. Watch your email for continued updates.

Also, while you are checking your calendars, mark June 14th to June 16th, 2026 for the 123rd NECA Annual Meeting and Conference. Rhode Island

An elegant cenotaph installed on Block Island.

A cenotaph is a monument memorializing a person or a group of people whose remains are located elsewhere.

This shared memorial was designed and installed by Karin Sprague Stone Carvers, in collaboration with Michael Shea, in the Island Cemetery. This monument commemorates those whose ashes are scattered on and around Block Island, RI, or those with a connection to Block Island who are entombed elsewhere. The triform, through-carved motif was conceived and realized by sculptor Rob Gil, emerging from his fascination with architectural tracery. On each side of the black slate is space for 12 names and dates. I've already had the honor of inscribing two names on the stone, those of Elva and Ralph Derby, my beloved caretakers as I was 19 living on the Island.
